Introduction

- 1. At their Twentieth Ordinary Meeting (Tirana, Albania, 17-20 December 2017), the Contracting Parties to the Barcelona Convention for the Protection of the Marine Environment and the Coastal Region of the Mediterranean and its Protocols, requested the Specially Protected Areas Regional Activity Centre (SPA/RAC) to finalize, in consultation with its focal points, the Classification of benthic marine habitat types for the Mediterranean region and the Reference List of Marine and Coastal Habitat Types in the Mediterranean, with a view to submitting them to the Contracting Parties at their Twenty-first Ordinary Meeting (Decision IG.23/8). In this context, SPA/RAC convened this meeting of experts that will take place, thanks to the kind invitation of the Government of Italy and financial support of the MAVA Foundation for Nature, in the premises of the Italian Institute for Environmental Protection and Research, ISPRA (Via Brancati, 48 00144 Rome, Italy), on 22 and 23 January 2019.
- 2. The following annotations to the provisional agenda have been prepared by the Secretariat to assist the meeting with its deliberations.

Agenda item 1 Opening of the meeting

- 3. The meeting will be opened on Tuesday, 22 January 2019, at 9 a.m., by the representatives of the host country, the Coordinating Unit of the UN Environment/Mediterranean Action Plan (UNEP/MAP) and SPA/RAC.

- 5. The relevant intergovernmental or non-governmental organizations have also been invited to designate their representatives to the meeting as observers.

It is proposed that the meeting be held in morning sessions: from 9 a.m. to 1 p.m., and afternoon sessions: from 2.30 p.m. to 6 p.m. on day 1, and morning sessions: from 9 a.m. to 1 p.m., and afternoon session: from 4.30 p.m. to 6 p.m. on day 2. The afternoon of day 2 will be dedicated to the adoption of the report, including the annexes.
- 10. It is expected that the meeting addresses all items of the agenda within the allotted sessions.
