Introduction

- 1. In accordance with the UNEP/MAP SPA/RAC Programme of Work 2022-2023 adopted by the 22nd Ordinary Meeting of the Contracting Parties to the Barcelona Convention and its Protocols (Antalya, Türkiye, 7-10 December 2021), the SPA/RAC is organizing the Meeting of the Ecosystem Approach Correspondence Group on Monitoring (CORMON) for Biodiversity and Fisheries, on 9 and 10 March 2023 in Athens, Greece.
- 2. The main objectives of the Meeting are to review the following documents:
