Report of the 5th Meeting of the Post-2020 SAPBIO

Videoconference, 30 April 2024

Introduction

- 1. The meeting aimed to inform about the Post-2020 SAPBIO implementation and its resource mobilization, as well as to discuss the proposed approach for its mid-term assessment as requested by the Contracting Parties at their 23rd Meeting (Decision IG.26/5, CoP23, Portorož, Slovenia, 5-8 December 2023).
- 2. The meeting took place online, on Tuesday 30 April 2024, from 2:00 to 5:00 p.m. UTC+1.

Participation

- 3. The meeting was attended by the following members of the SAPBIO Advisory Committee: Agreement on the Conservation of Cetaceans of the Black Sea, Mediterranean Sea and Contiguous Atlantic Area (ACCOBAMS), The European Topic Centre for Spatial Analysis and Synthesis (ETC-UMA), International Union for Conservation of Nature Center for Mediterranean Cooperation (IUCN-Med), The Mediterranean Experts on Climate and environmental Change (MedECC), the Network of Marine Protected Areas Managers in the Mediterranean (MedPAN), Oceana in Europe, Secretariat of the Union for the Mediterranean (UfM), and
- 4. The Mediterranean Action Plan-Barcelona Convention Coordination Unit (UNEP/MAP), the Regional Activity Centre for Information and Communication (INFO/RAC), the Regional Activity Center for the Priority Actions Programme (PAP/RAC), the Regional Marine Pollution Emergency Response Centre for the Mediterranean Sea (REMPEC) were represented at the meeting.
- 5. The Specially Protected Areas Regional Activity Centre (SPA/RAC) acted as the secretariat of the meeting.
- 6. The list of participants is included in Annex II to this report.

Agenda item 1: Opening of the meeting

- 7. The meeting was opened by Ms. Tatjana Hema, UNEP/MAP Coordinator and Mr Elyes Hamza, SPA/RAC Director
- 8. The agenda of the meeting is in Annex I of this report.

Agenda item 2: Update on the Post-2020 SAPBIO process and its resource mobilisation strategy

- 9. The SPA/RAC secretariat member presented the update on the Post-2020 SAPBIO implementation and the status of its resource mobilization since its adoption by COP 22.
- 10. The Advisory committee highlighted the necessity and the importance of Mediterranean countries including EU input to the status of the Post-2020 SAPBIO resources mobilisation since its adoption to have a clear overview of the financial resources put in place.

Agenda item 3: Assessment of the Post-2020 SAPBIO: proposed approach and the way forward

- 11. The secretariat presented the concept note for the mid-term assessment of the Post-2020 SAPBIO and its timeline.
- 12. While presenting the proposed approach for the mid-term assessment of the Post-2020 SAPBIO, the representative of Secretariat informed the meeting about the criteria to be used for the mid-term assessment of the Post 2020SAPBIO. The criteria are as follows:
 - a) Current Status: Evaluate the progress made on each start-up action since the adoption of the SAPBIO framework in 2021 based on quantitative and qualitative indicators for each priority action and target.
 - b) Comparison to 2027 Goals: Assess whether the targets set for 2027 have been achieved or if progress has been made towards their attainment based on quantitative and qualitative indicators for each priority action and target.
 - c) Path to 2030: Identify areas requiring additional efforts to meet the targets set for 2030 and outline strategies to accelerate progress based on quantitative and qualitative indicators for each priority action and target.
- 13. The meeting agreed on the Proposed Concept note and the Timeline to undertake the POST 2020 SAPBIO Mid-term Assessment as set out in Annex III to this Report.
- 14. The meeting welcomed the subregional approach to be used for both, the mid-term and periodic assessment emphasizing the importance of involving international consultants from the outset to develop the methodology prior to the mid-term assessment. It stressed the need for baseline at national and regional Level.
- 15. The Advisory committee highlighted the need to choose the right type of indicator, species, and habitats. The target could be assessed taking into consideration the subregion specificities.
- 16. In response to the various comments and requests by advisory committee members, the SPA/RAC provided the following clarifications:
 - a) Splitting the experts on a subregional basis has been proposed so that we continue with the same momentum and dynamics of the Post-2020 SAPBIO elaboration and this would be very helpful and less burdening especially for the country-level assessment. Recruiting experts on a thematic basis will be explored considering feasibility and financial resources.
 - b) Concerning the question regarding the importance of the Action to be assessed, it was clarified that the mid-term evaluation and periodic assessment will be based on the annex III of the Post 2020 SAPBIO, namely the Post-2020 SAPBIO Actions Table where there are only two priorities levels, high and very high.
- 17. There is a need to take advantage of data collection and reporting system under the Barcelona convention (IMAP, BCRS, MedQSR 2023 etc...), the status of MPA and under other fora like GFCM DCRF to feed the evaluation of progress.
- 18. The meeting endorsed the Proposed approach for the Mid-Term assessment as set out in Annex IV to this Report.

Agenda item 4 : Any other matters

19. No other question related to the topics of the meeting was raised by participants or by the Secretariat.

Agenda item 5 – Conclusion and closure of the meeting

- 20. The SPA/RAC director invited all the SAPBIO Advisory Committee members to attend the forthcoming SAPBIO National Correspondents meeting (5 June 2024, online) as observers.
- 21. The Advisory Committee members were invited to provide inputs to the SAPBIO resources mobilization status table, by email, no later than 17 May 2024.
- 22. Before closing the meeting, Mr. Elyes Hamza, Director of SPA/RAC, extended his appreciation to the members of the SAPBIO Advisory Committee for their attendance, and valuable contributions to the mid-assessment and evaluation process of the Post-2020 SAPBIO.

Post-2020 Strategic Action Programme for the Conservation of Biodiversity and Sustainable Management of Natural Resources in the Mediterranean Region (Post-2020 SAPBIO) Mid-Term Assessment: Proposed Concept note and Timeline

Ref:

- Decision I2G.25/11: Post-2020 Strategic Action Programme for the Conservation of Biodiversity and Sustainable Management of Natural Resources in the Mediterranean Region (Post-2020 SAPBIO)
- Decision IG.26/5: Specially Protected Areas (SPAs), Specially Protected Areas of Mediterranean Importance (SPAMIs) and Ecosystem Restoration

The Post-2020 SAPBIO:

1. The Post-2020 SAPBIO sets a visionary goal for 2050, to ensure a Mediterranean where marine and coastal biodiversity are valued, conserved, restored, and wisely used to sustain a healthy environment. The mission for 2030 is to initiate the reversal of biodiversity loss, putting Mediterranean marine and coastal biodiversity on a path to recovery for the benefit of both nature and people.

Goals and Targets:

- 2. Structured hierarchically following the CBD Framework, the Post-2020 SAPBIO outlines three overarching goals for 2030:
 - <u>Goal 1:</u> Reduce the threats to biodiversity.
- <u>Goal 2:</u> Ensure that biodiversity is preserved and maintained or enhanced to meet people's needs
 - <u>Goal 3:</u> Enable transformative change through the implementation of tools and solutions.

Mid-Term Evaluation Framework:

- 3. By 2025, the Specially Protected Areas Regional Activity Centre (SPA/RAC) will conduct a mid-term assessment of the collective implementation of the Post-2020 SAPBIO and Contracting Parties shall review their National Biodiversity Strategies and Action Plans (NBSAPs) accordingly to ensure the achievement of the Post-2020 SAPBIO objectives by 2030:
- 4. The mid-term assessment will be based on the Post-2020 SAPBIO Actions table (see annex III of the Post-2020 SAPBIO) and will be carried out by external consultants. The Terms of Reference (ToRs) for these consultants will be drafted based on the SAPBIO Advisory Committee and the SAPBIO National Correspondents meetings recommendations and input.

5. The SPA/RAC will consult the SAPBIO National Correspondents and the SAPBIO Advisory Committee, which will be actively involved throughout the assessment process, for input and guidance, in coordination with the UNEP/MAP. This collaborative effort will ensure a comprehensive and robust assessment.

Evaluation Focus:

6. The mid-term assessment will focus on determining the progress of Contracting Parties towards the targets set for 2025. It will assess the status of the startup activities which deadline of it implementation is 2025 and the feasibility of achieving targets by 2027, 2030, and beyond. Any identified gaps will be thoroughly examined, and priority actions will be updated to ensure the timely achievement of the three overarching goals.

Timeline:

7. The draft evaluation is scheduled to be completed in time for presentation at the 17th SPA/BD National Focal Points Meeting in the first semester of 2025. The timeline includes the following key milestones:

Post-2020 Strategic Action Programme for the Conservation of Biodiversity and Sustainable Management of Natural Resources in the Mediterranean Region (Post-2020 SAPBIO) Mid-Term Assessment: Proposed approach

Introduction:

- 1. As provided for in the Post-2020 SAPBIO (Decision IG.26/5), SPA/RAC will conduct a mid-term evaluation to assess the collective progress in implementing the Post-2020 and the Contracting Parties shall review their National Biodiversity Strategies and Action Plans (NBSAPs) accordingly to ensure the achievement of the Post-2020 SAPBIO objectives by 2030.
- 2. Targets and Actions (see annex III of the Post-2020 SAPBIO) which are quantified will serve as indicators of implementation progress allowing the timely analysis of progress based on objective/numerical elements of targets towards the Strategy Goals
- 3. The Post-2020 SAPBIO should be monitored as an alive/dynamic document, so the monitoring framework should need flexibility to allow adaptation. The Post-2020 SAPBIO implementation status should be periodically reviewed at the at the Conference of the Parties of the Barcelona Convention, through systematic national reporting of progress, facilitated by the relevant Regional Activity Centres including progress with regards to the implementation of the national contributions to the Post-2020 SAPBIO, and data on the Common Indicators of the Integrated Monitoring and Assessment Programme (IMAP) to monitor the effectiveness of the actions put in place.
- 4. To do so, international consultants will be recruited to assist the Regional Activity Centre for Specially Protected Areas (SPA/RAC) to define the necessary means for running the regional Post-2020 SAPBIO assessment mechanisms that should be put in place within the MAP system, and to conduct the mid-term assessment of the Post-2020 Strategic Action Programme for Biodiversity (SAPBIO) in the Mediterranean region and propose amendments for consideration by CoP24.
- 5. The evaluation process will encompass dedicated technical meetings, interviews, and an indepth review of relevant documents and reports. Crucially, the assessment will engage Barcelona Convention contracting parties through their designated Focal Points, UNEP/MAP components, and partners affiliated with the Advisory Committee of SAPBIO, alongside any other pertinent stakeholders.

6. In particular, the Targets and Action that will serve as indicators of the implementation progress are:

Objective: Strengthen conservation and protection efforts to preserve biodiversity and ecosystems in the Mediterranean.

Assessment Criteria:

- Current Status: Evaluate the progress made on each start-up action since the adoption of the Post-2020 SAPBIO framework in 2021 based on quantitative and qualitative indicators for each priority action 32 to 42.
- Comparison to 2027 Goals: Assess whether the targets set for 2027 have been achieved or if progress has been made towards their attainment based on quantitative and qualitative indicators for each priority action 32 to 42.
- Path to 2030: Identify areas requiring additional efforts to meet the targets set for 2030 and outline strategies to accelerate progress based on quantitative and qualitative indicators for each priority action 32 to 42.

International experts' selection:

- 7. Among the options under consideration, SPA/RAC proposes recruiting a team of 5 experts to conduct the assessment, prioritizing profiles with expertise relevant to the three goals outlined in the Post-2020 SAPBIO. It is proposed to proceed with the same approach used to develop the POST 2020 SAPBIO, a bottom-up approach based on the Mediterranean sub-region. To do this, it is proposed, to hire a team of experts as follows:
 - Lead Team Expert: To coordinate the assessment and compilation of information, providing inputs when relevant for governance and policy topics;
 - Expert to cover the assessment in the Western Mediterranean sub-region
 - Expert to cover the assessment Adriatic Sea sub-region
 - Expert to cover the assessment Aegean Sea and Levantine Basin sub-region
 - Expert to cover the assessment Ionian Sea and Central Mediterranean

- 8. Ideally, the selected experts should possess a combination of knowledge of the Mediterranean region's biodiversity and conservation challenges and policy/strategy analysis skills and evaluation. Here's a proposed profile for the experts:
 - Comprehensive understanding of the biodiversity, ecosystems, and conservation challenges specific to the Mediterranean region.

 - Proficiency in conducting policy/strategy analysis and strategic planning tailored to address the conservation needs of the Mediterranean region effectively.
 - Strong analytical and communication skills, enabling the effective communication
 of findings and recommendations to stakeholders and decision-makers within the
 Mediterranean context.
 - Proven track record of collaboration with regional organizations, government agencies, and stakeholders in the Mediterranean region to ensure alignment with regional priorities and commitments.
 - Familiarity with the Post-2020 SAPBIO framework and its objectives set for 2030 within the Mediterranean context would be an asset.
 - Good knowledge and working experience of the (i)implementation of the Barcelona Convention (ii) Ecosystem Approach (EcAp) process /Integrated Monitoring and Assessment Programme (IMAP)
