In September 1985, the Contracting Parties to the Barcelona Convention included the protection of the Mediterranean monk seal among their priority objectives for the second decade of the Mediterranean Action Plan (Genoa Declaration, 1985). To assist the Mediterranean countries in achieving this objective, the Regional Activity Centre for Specially Protected Areas, in collaboration with Mediterranean experts and concerned organizations, prepared an Action Plan for the management of the Mediterranean monk seal.

The main aim of the Plan was to reduce adult mortality, to establish a network of marine reserves, and to encourage research, data collection, rehabilitation, and information programmes for fishing communities and various other stakeholders. Within the framework of the implementation of this action plan several documents were prepared and a number of experts meetings were organized by RAC/SPA at different times:

Recently, RAC/SPA efforts focused on improving knowledge on the status of the species, training national partners, public awareness and the identifying of potential critical habitats in low-density areas (Albania, Algeria, Cyprus, Libya, Morocco, Syria and Tunisia).

Moreover, RAC/SPA supported activities on Monitoring monk seal population in some areas in Turkey and Greece via the use of photo trap.

As far as the interaction with fisheries is concerned, RAC/SPA produced guidelines and recommendations for reducing by-catch and reinforcing laws and regulations for the conservation and management of threatened species including monk seals.

The by-catch mitigation measures have been supported by the Sub-Committee on Marine Environment and Ecosystems (SCMEE) of the General Fisheries Commission for the Mediterranean (GFCM) and the Scientific Advisory Committee (SAC) for adoption proposal to the GFCM COP.

Collaboration with the GFCM on the issue is continuing by addressing a list of suitable caves for Monk seal existing in the Mediterranean countries, in order to have management actions for conservation of the surroundings of inhabited cave and to avoid conflict between coastal fisheries and the species.

With the aim to reinforce the commitment of the Mediterranean countries and their participation for the recovery of the species, the Contracting Parties approved during their last meeting (Marrakesh, 2009) the RAC/SPA proposal to prepare sub-regional programmes for the conservation of Monk seal in collaboration with the relevant conventions.

Therefore, RAC/SPA started an approach to craft these programmes for the conservation of the monk seal in the Mediterranean as follow:

- Preparation and update of National Action Plans in the countries with High monk seal-density areas: this is concerns Turkey and Cyprus, since we note that Greece has already prepared its National Strategy and Action Plan for the Conservation of the Mediterranean Monk Seal in Greece, 2009- 2015.
- Preparation of action plan for the countries presenting low monk seal density area: Morocco, Algeria, Libya, Tunisia, Syria, Spain, Italy...
- Harmonise sub-regional effort, in function of the different importance that sub-regions have for monk seal conservation.
- Draft overall regional programme based on these prepared documents and with reference to other reports elaborated by RAC/SPA.
- Discussion and finalization of this regional programme with the relevant conventions by the end of the year.
- Presentation of the regional programme to the Contracting Parties of Barcelona Convention.
